1. Information about the product	A blended mixture of essential oil and aroma chemicals

4. Appearance	Pale yellow to yellow liquid

6. Hazard identification	Flammable liquid. Harmful if ingested and enters air ways. Harmful in contact with skin. Harmful in contact with eyes. Harmful to aquatic life with long lasting effects.
7. First aid measure	IF SWALLOWED REPORT TO DOCTOR IMMEDIATELY. Do not induce vomiting. In case of inhalation - Remove from exposure site to fresh air, keep at rest, and obtain medical attention. In case of skin contact – Remove/take off immediately all contaminated clothing. Wash with soap and water. In case of contact with eyes – Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
8. Firefighting measures	PRODUCT IS FLAMMABLE LIQUID Normal firefighting precautions. Use of conventional extinguishers i.e. foam, CO2 and Dry chemical powder. Do not use water.

10. Handling and storage	<p>Keep containers out of direct sunlight, heat, sparks, open flames and hot surfaces. Keep in cool dry conditions at a temperature not exceeding 25°C.</p> <p>Keep tightly closed in the original containers or in plastic or plastic-coated containers. Limit oxygenation (contact with air).</p> <p>Use in areas with good ventilation.</p> <p>Do not eat, drink or smoke when handling this product.</p>
11. Exposure controls/ personal protection	<p>Ensure good ventilation of the work situation.</p> <p>Normal work hygiene practices.</p> <p>Wear Mask and gloves when handling.</p>
12. Stability and reactivity	<p>The product is stable. Presents no significant reactivity hazard, by itself or in contact with water.</p> <p>Avoid contact with strong acids, alkalis or oxidising agents.</p> <p>Do not expose to direct heat.</p>
13. Toxicological information	<p>Routes of entry – inhalation, ingestion and skin contact. This substance is nontoxic under normal conditions and is not classified in EEC listing.</p>
14. Ecological information	<p>Low degradability. Harmful to aquatic life with long lasting effects.</p>
15. Disposal considerations	<p>Dispose of in accordance with local regulations. Avoid disposing into drainage systems and into the environment. Empty containers should be taken to an approved waste handling site for recycling or disposal.</p>

Can cause taint but not classified as dangerous so no hazard label required. Ensure materials are securely stacked.</p> <p>This is an environmentally hazardous substance.</p>
