

Neroli Essential Oil Dilution (5%) - Material Safety Data Sheet

1. Information about the product	A blend of a fixed oil obtained from the ripe seed kernel of the sweet almond tree – prunus Amygdalus var. Dulcis, rosaceae and the essential oil extracted by distillation from Citrus aurantium var. amara
2. Product Code	06NE
3. Composition	Sweet Almond Seed, Neroli
4. Flavour and Odour	Slight odour; characteristic of product; Slight Fresh, Floral aroma from the Neroli
5. Appearance	A pale yellow to orange liquid

7. Hazard identification	Flammable liquid. Harmful if ingested and enters air ways. Harmful in contact with skin. Harmful in contact with eyes. Harmful to aquatic life with long lasting effects.
8. First aid measure	IF SWALLOWED REPORT TO DOCTOR IMMEDIATELY. Do not induce vomiting. In case of inhalation - Remove from exposure site to fresh air, keep at rest, and obtain medical attention. In case of skin contact – Remove/take off immediately all contaminated clothing. Wash with soap and water. In case of contact with eyes – Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
9. Firefighting measures	PRODUCT IS FLAMMABLE LIQUID Normal firefighting precautions. Use of conventional extinguishers i.e. foam, CO2 and Dry chemical powder. Do not use water.
10. Accidental release measures	Provide adequate ventilation and avoid inhalation. Avoid contact with skin and eyes.

11. Handling and storage	<p>Keep containers out of direct sunlight, heat, sparks, open flames and hot surfaces. Keep in cool dry conditions at a temperature not exceeding 25°C. Keep tightly closed in the original containers or in plastic or plastic-coated containers. Limit oxygenation (contact with air). Use in areas with good ventilation. Do not eat, drink or smoke when handling this product.</p>
12. Exposure controls/ personal protection	<p>Ensure good ventilation of the work situation. Normal work hygiene practices. Wear Mask and gloves when handling.</p>
13. Stability and reactivity	<p>The product is stable. Presents no significant reactivity hazard, by itself or in contact with water. Avoid contact with strong acids, alkalis or oxidising agents. Do not expose to direct heat.</p>
14. Toxicological information	<p>Routes of entry – inhalation, ingestion and skin contact. This substance is nontoxic under normal conditions and is not classified in EEC listing.</p>
15. Ecological information	<p>Low degradability. Harmful to aquatic life with long lasting effects.</p>
16. Disposal considerations	<p>Dispose of in accordance with local regulations. Avoid disposing into drainage systems and into the environment. Empty containers should be taken to an approved waste handling site for recycling or disposal.</p>
17. Transport information	<p>By road, rail, ship, air in clean and sound condition and full covered or airtight containers to protect from moisture, insects, and rodents. Can cause taint but not classified as dangerous so no hazard label required. Ensure materials are securely stacked. This is an environmentally hazardous substance.</p>
