3. Hazard identification	Flammable liquid. Harmful if ingested and enters air ways. Harmful in contact with skin. Harmful in contact with eyes. Harmful to aquatic life with long lasting effects.
4. First aid measure	IF SWALLOWED REPORT TO DOCTOR IMMEDIATELY. Do not induce vomiting. In case of inhalation - Remove from exposure site to fresh air, keep at rest, and obtain medical attention. In case of skin contact – Remove/take off immediately all contaminated clothing. Wash with soap and water. In case of contact with eyes – Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
5. Firefighting measures	PRODUCT IS FLAMMABLE LIQUID Normal firefighting precautions. Use of conventional extinguishers i.e. foam, CO2 and Dry chemical powder. Do not use water.
